January 8, 2024 Regular Meeting Minutes

Members Present: Supervisor Dan Ulrich, Sandra Witherspoon, Theda Williams and JB Hoyt. Kate Stewart was absent. A roll call was taken.

Agenda: Witherspoon made the Motion, with Hoyt supporting, to approve the agenda as presented. All in favor. Motion carries unanimously. **(M-01-24)**

Minutes: The Minutes of the regular meeting held December 12, 2023 were reviewed. Williams made the Motion, with Ulrich supporting to approve the minutes. All in favor. Motion carried unanimously. **(M-02-24)**

Treasurer's Report: Treasurer Williams was present to discuss the accounts as of the end of December, the General Fund: \$444,808.22; Water Fund: \$85,381.87; Fire Department \$359,408.50; Fire Department Bond \$82,975.42; Trust and Agency \$3,799.41.

Water Department: Dan Riley was present to discuss the Water Department. Water production was about same as last year. Lead service lines inspection deadline dates was changed to October, 2024. The generators were serviced in December. Riley did an analysis of unaccounted water and they are under 3% of unaccounted water. Working with Performance Engineering on reliability study. A cross connection control plan ordinance was discussed. Discussed the aviation light on the south tower. Would like to swap light to an LED when the water tower is getting worked on. Discussed creating a policy for emergency call outs.

Fire Department: Ulrich, Thorp and Seese met with the City of Charlevoix to discuss the purchase of a new fire truck. Would like to get truck ordered within the next week or two. The report was reviewed and discussed.

EMS: None.

Recreation Department: No report. Klinger has been working on the field house bathrooms.

Zoning Administrator Report: John Ferguson's report was reviewed and discussed. Discussed the status of the Master Plan.

City of Charlevoix and Charlevoix Township would work together for housing in the area. The grant will pay for land use policy, master plan updates; anything that increases housing supply. Requesting a letter of support to include in the Grant Application. John Kurtz spoke on the matter. Witherspoon made the Motion, with Hoyt supporting, made the Motion to provide the letter of support. All in favor. Motion carries unanimously (M06-24)
